**Tournament Entry Priority:** First priority to all 2009 Eastcape Anglers. Second priority to all TAA Lifetime members. Last priority is on order of receipt of applications.

**Changes:** If you plan to arrive early or stay late please make your own arrangements with Van Wormer Resorts 877-777-8862 or [www.vanwormerresorts.com](http://www.vanwormerresorts.com). But do it early because the Hotel is very full in June.

**Format:** 30lb test line (Ade "T" or Momoi IGFA Tournament in any color) Anglers supply their own line and at least two rods and reels. We fish two anglers per boat and use lures and live bait. Circle hooks must be used with bait. All bait must be purchased daily by the anglers. The Tournament will determine the amount of bait for each boat based on availability at the time,.

**Scoring:**

**200 points** plus bonuses for Marlin and Broadbill swordfish

**100 points** for Sailfish plus bonuses

**10 points** for yellowfin tuna, dorado, and wahoo. Daily boat limit 6 for each species
